

2019 SAINTES SUMMER HOOPS ACADEMY

For Girls entering grades 4-5-6-7. Open to anybody, not just SA students. Cost: \$100. Approximately 9 weeks to this summer training, ending before our Saintes basketball camp begins July 15. All workouts from May 13 through June 6 will be from 3:30-5:30 at SA. Need to access the Fieldhouse for June 10-11-13 from 12:30-2:30. June 17-18-20-24-25-27 back at SA 12:00-2:00. At the Fieldhouse again July 1-2-8-9-11, 12:30-2:30 to finish the academy. That is a total of 24 workouts for a reasonable price of \$100. Payable at start of the academy or \$50 to start, balance due June 10. The next week begins the Saintes Basketball Camp at SA, July 15-19.

Note for the 1st two weeks, May 13-14-20-21-23, while SA is still in school, we are dependent on the weather cooperating. If storms force varsity teams indoor to the gym, we lose our practice time after school. We would communicate a change in plans.

Led by 5 current and former head coaches Dick Wettengel, John Daley, Shawn Darrington, Tom Heithoff and T Gary White. We will also have guest help from former and current SA players including Alyssa Carley, Kylie Ferguson, Kalyn Wettengel, Bailey White, and others.

Our emphasis is on building skill for most of each session, then applying it to small-sided games at the end of each practice. (2v2 & 3v3) We stress improving fundamentals, working on decision-making skills, and trying to have fun.
